

CHURCH OF THE SAVIOR ANNUAL MEETING FEBRUARY 14, 2021

The annual meeting took place during morning worship via Zoom. The meeting was called to order at 10:35 a.m.

It was determined that we had a quorum as stated in the by-laws.

Patricia McBroom was appointed secretary of the meeting.

A motion to dispense with the reading of the minutes from the 2020 annual meeting was made by Allie Kennedy and seconded by Bill Topper. The motion was approved.

The meeting proceeded to the election of new vestry members. Pastor Dennett thanked outgoing members, Anna Brychik and Bill Topper for their service on the vestry. Michael Galbraith and Debby McKeon were presented as nominees for the two-and four-year vestry openings respectively. Sharon Steinmiller moved that Michael and Debby be accepted to fill the vestry openings as presented. Valerie Vitunic seconded. The motion was approved.

Jason and Hannah Wilson presented a report on the Village Church ministry. Because of the pandemic, their efforts have been centered on walking through the Village praying and talking with people who were willing. In addition to praying and planning for the future, Jason and Hannah have also been mailing notes of encouragement, artwork and Bible passages to the residents.

Allie Kennedy presented a report on the building improvements completed in 2020, plans for future improvements and maintenance and a summary of the funds raised and what is still needed.

Bill Topper presented the budget for 2021.

RECTOR'S REPORT

Dear Friends in Christ,

Far outstripping any other challenge to Church of the Savior in 2021 was the deaths within eight days of each other of two of our saints, Patty Tomazeski and Dee Joy. As we remembered their lives in the memorial service last month we heard testimony after testimony of the ways that in each of their lives God had displayed his love and power, both to encourage and to challenge us.

We should not think that with the end of the memorial service our time of grieving the loss of Dee and Patty has come to an end. Grief in some ways never really ends on this side of eternity. It recedes into the accepted background of our day-in-day-out awareness. The more we loved Patty and Dee, the more pronounced that ongoing grief will and should be.

At the same time, and thankfully, grief is not the entire story for Church of the Savior in 2021. If we are to weep with those who weep we should also rejoice where rejoicing is called for; and there is much about God's work among us in 2021 concerning which we can rejoice.

At last year's Annual Meeting, I outlined three things I sensed God calling us to in 2021: to work toward retiring our building mortgage, to begin cleaning out the physical junk from our building, and to rebuild our capacity for mission. A year later, we can take encouragement from the significant progress we have achieved on all three goals.

As you can read in our Building Maintenance Campaign report, in 2021 we made great progress on reducing the mortgage principal, with a \$25,000 payment in mid-summer, and the funds on hand at year end for another substantial payment to be made. We appear to be well on our way to fulfilling the challenge of **retiring the mortgage** before the end of 2023.

You can also read the details of the **building cleanout** in the same report. Once again we made substantial progress on this goal in 2021; at the same time, more work remains to be done, with the need for a second major cleanout day later this spring. Preparing for that cleanout also led me to produce written building and office manuals which should help us both now and in the future avoid having to reinvent the wheel as we encounter various needs.

As we are removing storage items no longer needed, our need for **creative development of our space** becomes more evident. This is especially the case with regard to our capacity to welcome children and their families, long a vital value in the life of COTS. As we continue our cleanout, I look forward to a team of parishioners reflecting creatively on the best ways our space can be used to welcome people, especially those not currently members of COTS.

When we reoccupied our sanctuary after a three-month absence in early July 2020, I challenged us to undertake the work of **replanting Church of the Savior**. I was under no illusions in stating that challenge; planting a church is hard work that requires both creativity and sacrifice. At the same time, no one who looks around our sanctuary on a Sunday morning, with the increasing number of empty seats, and the increased age of many of those sitting in the seats that are occupied, can doubt the need.

The need to replant presents a far greater challenge than raising money to repair our building and retire the mortgage, which has been relatively easy to do by comparison. Hence when we resumed our capital campaign in the fall by reaching out to an expanded circle of COTS alumni and friends, we included a second request: that people consider who they might refer to come join us in our ministry in Ambridge (or even consider coming themselves!).

Humanly speaking, the request was presumptuous. Not surprisingly, to date no one has taken us up on it. And yet, God does seem to be doing something else that may be even more important — stirring up the nucleus of a team that together will pursue an integrated outreach vision for COTS. We've seen the first fruits of that venture in 2021, with the team's work on a renewed **Vision and Purpose statement**, grounded in listening prayer together, in a review of the many ways God has spoken to our gathered community over the years, and in prayer walking our ministry contexts. I am grateful to Anna Brychik, Allie Kennedy, Pat McBroom, Bill Topper, Deacon Laura Wicker, and Jason and Hannah Wilson, for joining in listening for the Lord's direction that is so vital to our future.

Lastly, although there is repetition with many of the names, I want to offer my **thanks to those who have served as COTS leaders** in any capacity during 2021. I'm grateful to the Wilsons and Stephen and Abby Crawford for their perseverance in keeping us connected to the residents of **Economy-Crestview Village** throughout the pandemic. Even though there's been no opportunity to meet formally, they've still been able to serve people in a number of ways.

I am thankful for the wisdom and counsel of our **Vestry**: retiring members Senior Warden Allie Kennedy and Pat McBroom; also Michael Galbraith and Debby McKeon. Another highlight of 2021 has been streamlining Vestry procedures and meeting by Zoom. Together these changes have focused the Vestry's influence while lessening their workload.

Mark and Sarah Kwolek, Carla Hill and Anna Brychik have provided profound leadership for our **music ministry**; time and again the Holy Spirit has moved through them to confirm the Word read and preached either through prophetic ministry or simply through a marvelous correspondence with the selected songs. Pastor Andrew Kosarik — whose report you can also read — and Hannah Wilson have helped maintain our **online** presence. Just recently we've seen an increase not only in our Sunday viewers, but in folks visiting our services on YouTube at other times during the week.

In my address, I will say more about our plans for 2022. There is no question that in the year ahead we will face significant challenges, both known and unknown. But what I said last year remains the case today: I have never been as expectant concerning what the Lord will do at Church of the Savior as I am now. God has a great future for us in his Kingdom, walking together in loving obedience to Jesus and his commands. Let's enjoy the walk together!

VILLAGE CHURCH REPORT

This has been a difficult year for all forms of ministry, Village Church was certainly no exception. With covid in full swing and the community center building closed, we started the year doing prayer walks around the community. We sent out quarterly mailings with holiday cards, scriptures, and words of encouragement which were well received. Several people recalled the letters when we introduced ourselves on prayer walks.

As time went on we prayed and racked our brains to come up with other ways we could engage the community. We began relationships with a half dozen or more people who we met through our prayer walks and delivering food boxes. Many of these people espoused an interest in having services or meetings of some kind. Eventually we met one resident of the Village who was interested in helping me start a service. She was proactive and excited. She did the leg work of talking to people to let them know we were going to start meeting at the basketball courts. We were hopeful that, after so much prayer we had finally found our person of peace, a gateway into the community. Unfortunately this too would sputter and fail.

The overwhelming trend we see in the Village is verbal affirmation of interest, but no willingness to show up or to be consistent. It is my belief that a prayer walking ministry is vital to maintain a relationship and presence in the Village, but lacking interest suggests that that is the full extent to which people are open to long term ministry at this time.

ONLINE CHURCH REPORT

Change is a constant in life and the pandemic was not different. Rightly as things on the ground calmed down our viewers who were joining us from far away, began joining their local congregations. Over time COTS members did the same. We were blessed to have each person be part of our online worship experience for this season and thank them for joining us in virtual worship.

Currently weekly attendance is between 10 to 25 people per week with 3 to 7 guests (those not logged in). Over 28 COTS members have used the online feature in some way over the last year. Regular attenders are around 11, seasonal attenders are 4 and those coming as needs arise throughout the year are another 12. Like normal church there was a dip in attendance over the summer. In the winter our numbers tend to go up.

We continue to link the online and in person communities together through our shared prayer requests sent out weekly via email. Online and in person folks get to see each other's needs, better to connect as we support each other.

Our research indicated that deeper efforts to link the two groups, while a great goal, did not work well for most churches. Instead, the online community would be a resource meeting our seasonal, temporary, or long term needs during this fuzzy and ever changing landscape of the pandemic.

We have also sought to use our online presence to create opportunities for community, both during our Sunday worship and afterwards. Community in the virtual space is different: You can't hug someone or have an in depth conversation in virtual space.

During the service we use the chat feature as a way to connect and check-in with one another. We encourage everyone to share what is going on in their lives and for everyone to comment and pray with responses in the chat. This can not replace conversations, but it allows for connections to occur in real time. I try to comment and connect with everyone as well so that everyone is feeling heard as does the on site host. I also pray in the chat so needs can be lifted up immediately, just as if the people were standing in front of me. We also encourage our participants to do the same, so we can build each other up.

At times we have also utilized the chat as a means of discussion and comment about Scripture readings and sermons. We learn from each other and grow as we engage in God's Word together. We have had some very fruitful times of discussion.

Finally during times of crisis, the chat feature has become a place where people can share what they are feeling, and we can comfort one another through our responses, in place of physical hugs.

We have also continued our after church Zoom time. Folks have the opportunity to connect once a month (the first Sunday) for a virtual coffee hour and for a short,

weekly time of prayer on Zoom. We come to together and share our needs and lift up those that have been put in the chat and any that we have heard shared in the congregation.

Our focus has been building community, and we hope to be able to address new needs as they are brought to our attention. There are many ways we can use the virtual space, so feel free to let us know your needs, so we can create virtual solutions that will glorify God and bring us together. In this space we can invite our family, friends, coworkers and neighbors to come and see what makes Church of the Savior special without the need to leave the comfort of their home. In that space we hope they will meet with God in a deeper way and experience His love. So I encourage you to think of people you know who could be blessed by virtual worship and take a chance to invite them to tune in to God's Spirit online.

Our Bible Study was a continuation from the previous year of the movie clip Uncondemned from Deaf Missions with questions from John 8:1-12.

Deaf Bible study is held on the second Sunday of the month from 3-5 PM on the first floor. In the later part of 2021 we started a new type of Study from Deaf Missions. The scripture was told as a story that was dramatized in a video. Our group appreciated this format better because it communicated in their heart language and this helped them to remember the scripture.

Highlights of 2021:

- Our Interpreter, Kathryn Betcher moved back to Florida in November to help take care of her Mother's health needs. We were sad to see her go.
- The annual Sign-A-Thon at Robinson Mall hosted by the Center for Hearing and Deaf Services was canceled because of COVID. The Deaf come together from Beaver, Butler, Allegheny and Westmoreland Counties plus counties near Erie.
- In the spring we were blessed to have students from Geneva College's ASL class (Instructor Carla Hill) participate in our Sunday Bible Studies. For some of the students this was the first time they were interacting with the Deaf. Because of COVID restrictions we used the Sanctuary so we could spread out.

- During the year there were some Beaver County Deaf get-togethers at the Chippewa Hot Dog Shoppe on Fridays. These are scheduled when we can secure the room in the back of the Shoppe. COVID has made these get-togethers harder and harder to schedule.
- Donna Wright, one of our Deaf leaders sends out the emails for Deaf Bible Study and Janet Heid sends out the emails for the Hot Dog Shoppe. Their help is such a blessing.
- There were four Sundays of Interpreted services in 2021.
- In December we had our Christmas celebration. Our friend, Interpreter Lisa Labon signed for our Communion Service led by The Rev. Dr. Dennett Buettner and the Rev. Andrea Buettner. They were able to stay and watch our Bible Study. We were also blessed with a wonderful meal made by Carla Hill's daughter.

DIOCESAN ACTIVITIES IN 2021

As was 2020, 2021 has also been a challenging year in the life of our Diocese. After the resignation of Bishop Jim Hobby in late October 2020, the Standing Committee became the functional Ecclesiastical Authority. The Standing Committee is the equivalent on the Diocesan level of a parish Vestry. The Standing Committee is composed of four clergy and four lay members who are elected annually in rotation, one in each order for a term of four years. The Standing Committee has had to make most of the significant business and personnel decisions in the Diocese in 2021. Its members have worked very hard to keep the Diocese functioning.

The same is true for Sarah Kwolek in her role as Diocesan Director of Administration. A significant improvement in Diocesan life in which both Sarah and the Standing Committee have played a part has been the changes made in the Diocesan budgeting process. The outcome has been much greater transparency in that process, and a more realistic assessment of the actual financial condition of Diocesan operating funds. I am personally much indebted to Sarah, and very grateful for her sacrificial service to the clergy and lay members of our Diocese.

COTS, as all Diocesan parishes, is asked to tithe to the Diocese its annual operating income, and in 2021 we continued to do so. Although our operating income fell below the Diocesan target, we were still able to meet the pledge we had made of \$11,600, and give an additional \$650.00 to the Growth Fund – a Diocesan fund used to make loans to parishes for capital improvement projects. COTS has benefited from these funds a number of times in the past, most recently in receiving assistance for the closing costs when we refinanced the building mortgage in 2018.

During 2021, Bp. Martyn Minns has served as our interim Bishop. Bp. Martyn has been retired for some years, but you would never know it from his enthusiastic and energetic leadership. He met with our leadership team for prayer in October and

conducted his official visitation on Sunday October 31. First time I've ever seen a Bishop dance and play a tambourine! Bishop Martyn has also been extremely encouraging on the occasions when I've had personal conversations with him. He clearly has affection for us and understands our vision to care for people that others might not see. I am aware that he has suggested to several individuals and families that they should consider connecting with us.

In recent weeks, two members of the parish, Tony Hermankevich and Stephen Crawford, have approached me to inquire about pursuing ordination. I am in the beginning stages of conducting the required (and extensive) personal interview process with each of them before constituting, if appropriate, a lay discernment committee.

During 2021, the Standing Committee also appointed a Search Committee to nominate candidates for Bishop. It was an honor, and a recognition of the important place Church of the Savior occupies in the wider Diocese that Deacon Laura Wicker was one of five clergy appointed to the Search Committee of nine members in all. The slate of three candidates has just been announced. They are: the Rev. Alex Cameron from Chicago; the Rev. Peter Frank from Virginia; and the Rev. Joel Scandrett, from the Trinity School for Ministry faculty.

The candidates will be visiting the Diocese for a series of get-acquainted meetings with clergy and lay leaders the week of March 21, with the election scheduled to take place at St. Stephen's Church in Sewickley on Saturday April 30. Assuming that the required approval of the Anglican Church in North America House of Bishops is obtained, the new Bishop would be consecrated in late summer or early fall 2022.

Our lay delegates to the electing convention will be Anna McKeon and Jason Wilson; and you can speak with either of them, or any of our clergy, if you have questions or concerns. More information on the candidates and election process can be found online. I have provided and will continue to provide links to election news updates via our weekly emails.

BUILDING MAINTENANCE CAMPAIGN REPORT 2021

In 2017 the Vestry established a comprehensive plan for major maintenance, upkeep and improvement for Church of the Savior's building. At the top of the list were crucial needs like roof replacement and masonry repair as well as the compelling concern to improve the appearance of our sanctuary. Initial estimates of the cost of a comprehensive project came to about \$335,000 – in 2017 dollars.

Since then, several new elements — most notably price inflation and early discharge of the building mortgage — have contributed to increasing the cost of the original project. We anticipate that the total cost of all items in the project as it now stands will be a bit more than \$410,000. As of the end of 2021 we have already incurred over \$175,000 of those expenses.

You can read about prior years' expenses in our previous annual reports. In 2021 our campaign achieved one major goal and made a significant beginning toward another. During the early spring, Arch Masonry of Pittsburgh restored damaged masonry on our north-facing wall and the cornice at the top of the building at a cost of just under \$41,000. While repointing the other three sides of the building remains on our campaign list, the need is much less urgent. In the meantime, as with roof replacement in 2020, our donors' generosity enabled us to complete this part of our project a full two years early.

Capital funds also enabled us to begin a major cleanout of our building. Sensing that the Lord was saying it was time to clean out items that represent a past from which we need to move on in order to welcome new people, in late April we filled a 10' dumpster; then in August we recycled nearly \$1,000 worth of unused electronics and paints at an event sponsored by the Borough of Ambridge. In both instances, many of the items disposed of had been in the building since the time we moved in, in late 2004!

In view of these significant accomplishments, during 2021 the COTS Vestry voted to add retirement of the building mortgage as a part of our overall campaign. By mid-summer enough funds were on hand that the Vestry was able to authorize an initial \$25,000 payment to principal while still retaining sufficient funds in hand to address an emergency need, should one arise. By year end 2021 the remaining principal balance on the mortgage had decreased to just under \$120,000.

2021 also saw advances on the income side of our campaign. In March 2020, just before the pandemic hit, Sarah Kwolek had conducted a training for people interested in reconnecting with COTS' "alumni" – members who have been part of our community in the past but whom God has called on to other places. That effort was immediately curtailed by the pandemic; but in late August 2021 the group of callers reconvened for a re-training.

During the fall, we reached out to an initial round of fifty persons we had identified as most likely and able either to partner directly with our effort, or to refer us to others who might partner with us. After we sent an initial letter, seven parishioners and one alumnus friend made efforts to connect either by phone or email with each person on our list. These efforts netted \$12,000 in new donations to the capital campaign; more significantly, we were able to reestablish connection with old friends.

Here is the breakdown on capital campaign giving from the start to now:

As you can see our giving has increased year by year, and the two best years have been pandemic years when we perhaps should have expected to receive less funds for building needs. To God be the glory!

The charts display the overall progress of the campaign through the end of 2021. In all we have raised almost \$250,000 toward the goal of \$410,000 (right top); so we are more than halfway there! Just under half the amount raised has come from COTS members (right bottom).

In 2022 the campaign continues. Our next goal is the discharge of the building mortgage. The principal balance at year end 2021 was just under \$120,000.



Notes:

Overall: Fixed costs and service fees are projected for an across-the-board increase of 10% during 2022, owing to continuing financial turmoil. These include: copier maintenance (l. 42200 and note 12 below); all insurance premiums (ll. 43100 and following); payroll service (l. 43400); all utilities (ll. 44200 and following); and elevator maintenance (l. 44320 and note 20 below).

Property insurance is estimated to increase by 25% owing to the 2021 increase in the value of goods insured on our policy, rising costs of defending against cyber attacks, and inflation.

Electric and gas rates are projected at an additional 10% increase (that is, a total increase of 20%) owing in part to anticipated inflation in rates and in part to restoration of the usage level of 2019 and previous years. Water service, while not as severely impacted, is nonetheless budgeted to cost 15% more in 2022 (10% inflation, 5% restoration of prior level of use).

Accordingly this budget also projects a 10% wage increase for support staff.

- The opening balance for 2022 is derived as follows: The December 2021 financial report shows a net operating surplus for the year of \$23,346.49. Additionally \$29,728.74 was carried over from 2020 to 2021; however, of that amount a net of \$17,628.21 was spent on non-operating items, mostly related to the capital campaign. The net year-end operating surplus for 2021 is the of the first two numbers minus the third, or \$35,447.02. The Vestry's January 17, 2022 decision to pay \$50,000 toward principal on the building mortgage necessitates the restriction of an additional \$14,660.25 of retained operating funds for 2021, reducing the net surplus retained in the 2022 operating budget to the amount reported on line 1000
