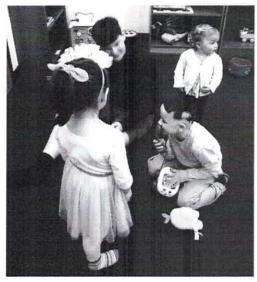

CHURCH OF THE SAVIOR ANNUAL MEETING FEBRUARY 20,2022

The annual meeting took place during morning worship. The meeting was called to order at 10:31 a.m.

A motion to dispense with the reading of the minutes from the 2021 annual meeting was made by Andrea Buettner and seconded by Jason Wilson. The motion was approved.

The meeting proceeded to the election of new vestry members. Pastor Dennett thanked outgoing members, Allie Kennedy and Patty McBroom for their service on the vestry. Sharon Steinmiller and Bill Topper were presented as nominees for the two-and four-year vestry openings respectively. The nominees were approved by acclamation.

Michael Galbraith has agreed to serve as the Senior Warden of the Vestry

Allie Kennedy presented the 2022 operating budget for Church of the Savior.

Michael Galbraith presented a report on building maintenance and the capital campaign.

Pastor Dennett presented a summary of life at Church of the Savior in 2021 and God's continued faithfulness to us.

Detailed reports for all ministries and finances, including the 2022 budget, can be found in the Church of the Savior Annual Report 2021 submitted to the congregation and made a part hereof.

Michael Galbraith moved that the meeting be adjourned; Mark Kwolek seconded. The motion was approved. The meeting adjourned at 11:28.

RECTOR'S REPORT

Dear Friends in Christ,

As in the prior year, 2022 for Church of the Savior was a year marked by losses of dear friends. There were few if any COTS members who did not experience the death of one or more loved ones during the year; all of us feel deeply the loss of our beloved Bishop, patriarch, and friend, John Rodgers, who went home to be with Jesus Thanksgiving week. Deep loss for us, but unspeakable and unimaginable gain for Bishop John. We were both encouraged and challenged by the memorial service for John last month; at the same time, how could any remembrance really do justice to his rich legacy?

As I reminded us last year in similar circumstances, we should not think that with the end of the memorial service our time of grieving has come to an end. Grief in some ways never really ends this side of eternity. It recedes into the accepted background of our day-in-day-out awareness. The more we loved our family members who passed away in 2022, the more all of us loved John Rodgers, the more pronounced that ongoing grief will and should be.

At the same time, and thankfully, grief is far from the entire story for Church of the Savior in 2022. There has been much in this year that speaks of God's favor, of new opportunities for his Kingdom, and new life among us.

To begin with, there are more reports in this document than in recent years. As we have begun to come out of pandemic mode, many ministries that were put on hold (children, nursery, Kyrie Café, for instance) have resumed; and there are new ones as well (the Manasterskis' house church, a team of intercessors) as well as new roles for Jason and Hannah Wilson as coordinators of parish ministry and of hospitality, respectively.

As always, I strongly encourage COTS members to read this document. I believe you will be greatly encouraged to see evidence of the ways God has moved at COTS in 2022, evidence that affords a hopeful trajectory for the future.

Two years ago we discussed three major goals for Church of the Savior as we began coming out of pandemic mode: retiring our building mortgage, reorganizing the building, and rebuilding our capacity for mission. In 2022 as in 2021 we have made genuinely encouraging progress in all these areas.

At the beginning of 2022, we made a \$50,000 payment toward principal on the **building mortgage**, reducing the outstanding principal at that time from roughly \$120,000 to \$70,000. This was on a loan, originally \$404,000 when it was first entered into in 2004, that had only been halved to \$202,000 when we refinanced fourteen years later, in late 2018. During the course of 2022, regular monthly payments further reduced the principal balance to just under \$47,000. On January 5 of this year, we delivered a check to Sewickley Savings Bank for the full outstanding principal amount; the mortgage has now been satisfied and discharged.

Ten years ago, when we were initially considering a capital campaign, Sarah Kwolek consulted with our Vestry from her experience in the world of professional fundraising. Her comment was: "Typically when you're considering undertaking a capital campaign, you do a

feasibility study first; but this campaign clearly isn't feasible, so we don't need to!" Not feasible, by human ingenuity and effort; but entirely feasible for God.

Over the past five yearsm for much of which time "ordinary" life was brought to a standstill by the pandemic, little Church of the Savior has been able to raise the funds not only to pay nearly \$125,000 in mortgage principal but also to undertake other major renovations: a new roof, a rebuilt weather-facing exterior wall, and many improvements in our sanctuary – all these ahead of what we thought was the optimal possible schedule. And almost half the funds – 45% to be exact – have come from our own members. This is an amazing feat, for which God deserves great glory! He has truly done great things!!

This spring we had a second **cleanout day**. For the second year in a row we completely filled a 20 yard dumpster with clutter. The building cleanout has enabled consolidating our work space by relocating the administrator and bookkeeper functions next to the rector's office and moving the workroom into the former reception area. The vacated spaces can now be available as part of a more child- and youth-friendly space for future ministry.

At the same time, cleaning out the old to make room for the new is more than a merely physical reality. As one of our members said to me the day after the first cleanout day in 2021, when you came into the building you could feel the difference. Who can say that there is no connection between removing old stuff from our building and the welcome additions we have seen in the past year especially of new members and new leaders? Or who would want to say that there may not be more new to come?

As we have said all along, while caring for our building is important, the reason we do so is to enable the even more **important work of ministry** that takes place here. I'm grateful to Deacon Laura Wicker and Abby Crawford for their initiative in leading the Maplewood Personal Care Home study. Pat McBroom has taken over leadership of the Kyrie Café as Martha Ory has had to move into assisted living; I'm thankful for her prayerful supervision of this ministry, and especially for the work of Pastor Myron and Marianne Manasterski in restoring a culturally-sensitive offering of worship and the Word of God to the lunches.

Valerie Vitunic and a team of volunteers have made sure that our nursery is staffed weekly. I want particularly to thank Micah, Jono and Anna Kwolek for their selfless service, making sure that our adult volunteers are able to serve on a six-week rotation. And I cannot thank Mike and Sukie Casas enough for their investment in restarting our church school.

One additional word is in order concerning these fledgling children's ministries. For most of the year, we have had only one or two children in the nursery, and two children in church school. But in offering these ministries now, we are laying the foundation for a vital element of God's preferred future for Church of the Savior. In a sense, by serving in such limited circumstances, our volunteers are enacting our prayer that the Lord would increase these ministries – as we know will have to happen for Church of the Savior to enjoy a vital and healthy future. I encourage us to keep our eyes on these two ministries in coming months and years, and see how faithful the Lord will prove himself in answering these prayers!!

We have also continued our online ministries, livestreaming and archiving the weekly Sunday worship services; and leading midweek online Koinonia Groups and Bible studies. This year I've enjoyed teaching through the 39 Articles and on hearing God. I'm especially grateful to Hannah Wilson for her help in keeping our online and internet presence operating and for troubleshooting when that is a need.

Elsewhere you'll read about the ministry of our parish intercessors, whom Sharon Steinmiller has convened to pray weekly for COTS, our needs and vision as a parish. No other development in 2022 has been more encouraging to me – not even the discharge of the building mortgage! In the history of the Church, revival always follows when God's people pray corporately. I expect to see him do great things here in coming months and years!

I cannot close without a word of appreciation for our Vestry: retiring member Senior Warden Michael Galbraith, Deborah McKeon, Sharon Steinmiller and Bill Topper. God has gifted us with men and women of prayer, discernment and compassion as our leaders and I am so greatly blessed to be able to work with them.

On the world scene, 2023 appears to be a year of significant challenges and of navigating uncharted waters. Nonetheless we serve a God who holds that future in his hand, and can and will enable us to prosper in ministry that builds up his Kingdom, within us and among us. I join you in expectant anticipation of what he will do in the life of Church of the Savior in this year to come!

SENIOR WARDEN REPORT

I've summarized the main issues the Vestry has dealt with in 2022.

As we're all aware, again we have loss and grief this past year, especially toward the end of the year, the chief being the passing to Glory of our beloved Bishop John. What a blessing: of all the congregations he could have attended he chose little Church of the Savior. I'm reminded of how God chose little Bethlehem for the birthplace of our Savior. Also it was another year of COVID, several parishioners with major health issues, and many with personal or family losses.

But God is God, and as we are all aware His ways are not ours.

While these things were tough, the Lord has also blessed us with new families and some of these folks have taken on new ministries. I am especially thankful for the Casas teaching our children and Birttnee Busse joining the intercessors for the parish.

The next item would be our building. We have again had one major day of decluttering of the building, filling a 20 yard dumpster. The amazing part of that was how much of the contents were gone on Sunday (the next day) by drive by persons recycling items.

We contracted with Tony Hermankevich to renovate the sacristy and ambulatory areas. This has been an issue for years, with disrepair, half demolished and half finished, and with awkward steps in the middle. Now the floor is level and the area is completely refinished.

In November we also contracted with Tony to start repairs and renovations to the stage area. The refinished stage looks great! We still need to update our audio/sound wiring and equipment.

Through the congregation and outside contributors we have been able to pay for all these renovations and I'm pleased to say we'll be retiring the mortgage in January 2023. Praise God for his faithfulness to us and to each person and group that has been so gracious to bless us in their abundance. Thank you!!

Outreach has been stagnant except for the Kyrie Café. Due to COVID there are still many things affected by it. But we still have Twelve Step groups meeting in the building, the healing care group and Bible studies. That is very encouraging to me. It seems we might be getting back to a new normal.

Prayer has been a focus as well. We have intercessors praying before our service every Sunday and through the week as well under Sharon Steinmiller's leadership. We have heard some words from the Lord regarding his vision and plan for Church of the Savior. In January we are taking an early morning to hopefully with the Lord's grace focus on both.

Lastly, we have encouraged Dennett and Andrea to take rest and vacation; and this past year it was about four weeks, and much deserved. Also Dennett was able to attend the New

Wineskins missions conference as well. While there the Lord spoke to Dennett about the online class he is now doing on "Hearing God." If you've not joined in, I encourage you to try it, or to check out the recordings on COTS" YouTube channel. It has been helpful and a blessing.

It's been my pleasure to serve the Lord and COTS as Senior Warden this year. Thank you for your trust in me and the Lord's blessing.

ONLINE PASTOR REPORT

The pandemic birthed our online Sunday ministry out of all of our shared need. Thankfully those limitations are a distant memory, but our ministry continues to meet the needs of those who cannot join us each Sunday. A team of volunteers is here each Sunday providing a way to connect virtually with God's people and worship Him together. We are so blessed by this group of volunteers doing the camera work and the technical wizardry to make the online service work. Regardless of the reason, everyone is welcome to join us online when they can't be present at worship whether because of health or other issues, or because the alarm simply didn't go off.

I'll be in the public chat each week. I try to connect with everyone who joins and check in to see how life is going, just like you might expect someone to greet you in church. I will try to pray with you in the chat and offer words of encouragement if I can. And while the public chat can't reproduce non-verbal cues, it still does allow for discussion and an exchange of ideas, especially when it comes to the readings and the sermon. I and others will share thoughts and insights as we learn together. At times we try to keep things light and just chit chat when possible so people feel like this is less like a TV show and more like a community away from church. Of course some things are not meant for the public consumption, and I try to connect when people ask for prayer through the private prayer request button or through a direct chat feature that brings up a separate chat box. When appropriate, I try to follow-up after the service via email and connecting over the telephone. And of course I lift their prayer needs up through the week as well. If concrete needs are presented that the Body of Christ can assist with, I also try to connect people with those who can help.

It is true that nothing can truly take the place of in person worship, but we are trying to create the next best thing when life won't let you get to church. So I encourage everyone who comes to engage in the online community as you would in normal Sunday morning by engaging everyone in the chat and sharing your love with everyone who is online.

As life changes in the short term or the long term, we will be here to help you stay connected to the Body of Christ and worship God together. Click, connect and worship God together. Come and be part of the family of God.

I have every expectation that each of them is going to expand in the coming months and years to serve more families and children, so that each will require its own report, by a leader set apart for the purpose. Signs of Grace Fellowship has been blessed by the ongoing support of the leadership and the congregation of Church of the Savior. THANK YOU!

Our Bible Study was a continuation of the Study from Deaf Missions. The scripture was told as a story that was dramatized in a video. Our group appreciated this format better because it communicated in their heart language and this helped them to remember the scripture. Deaf Bible study is held on the second Sunday of the month from 1:30-3:30 PM on the first floor.

Highlights of 2022:

- In the spring we were blessed to have students from Geneva College's ASL class (Instructor Carla Hill) participate in our Sunday Bible Studies. For some of the students this was the first time they were interacting with the Deaf.
- During the year there were some Beaver County Deaf get-togethers at the Chippewa Hot Dog Shoppe on Fridays.
- Donna Wright, one of our Deaf leaders sends out the emails for Deaf Bible Study and Janet Heid sends out the emails for the Hot Dog Shoppe. Their help is such a blessing.
- SOG members along with some family members attended the CODA (Child of Deaf Adults) Movie at the Tull Family Theatre in Sewickley. The movie explained the responsibilities that a hearing child may experience growing up with Deaf parents
- We planned a picnic with COTS but it rained and we had our picnic in the Church Basement
- We had various Interpreters during the year, but it is getting harder and harder to find one who is available. The need is great and we may have to turn to technology to use Interpreters.
- We welcomed Bailie Rohr, a student at Kent State University who is studying to become an Interpreter, She joins us when she is home for the weekends
- In September Carla Hill and Flora Galbraith went to the New Wineskins Conference at Ridgecrest, NC. We went to coordinate the ASL Interpreters, help the Deaf leaders who came to participate and were involved with the technical setup. We were joined by Kathryn Betcher who assisted with the Interpreters. This was all done through DEAFCHURCH Together. This was the first time the conference was interpreted in ASL. It was a blessing for the Deaf and hearing.
- We had our first Oktoberfest this year. We invited the Deaf community and also the congregation of COTS. We had traditional foods along with apple cider. We played Bingo and had other games available. We found out that the Deaf Club in Pittsburgh had a Bingo event on the same day and time. We won't do that again!

PARISH MINISTRY COORDINATOR REPORT

Over the past year my role with Church of the Savior has changed significantly, though I still keep quite busy. As we closed the doors of Village Church we grieved the ending of one ministry and looked forward to new ministries.

DIOCESAN ACTIVITIES IN 2022

After several years of turmoil following the COVID pandemic and the resignation of then Bishop Jim Hobby in late October 2020, 2022 saw the election of a new Bishop. The Rev. Alex Cameron, from the Diocese of the Midwest, was elected on the first ballot at a Special meeting of Diocesan Convention at St. Stephen's Church in Sewickley on April 30. COTS was represented at the election by our clergy, Pastor Myron Manasterski, Deacons Laura Wicker and Andrea Buettner, and myself, and by Jason Wilson and Anna Brychik. Following his election, Bishop Cameron was approved by the Anglican Church in North America College of Bishops at their meeting in June, and was consecrated in a worship service at the Church of the Ascension in Oakland on August 6.

I've had the opportunity to meet twice with Bishop Cameron since his consecration, to acquaint him with the general circumstances of Church of the Savior, and to introduce to him our two prospective ordinands, Tony Hermankevich and Stephen Crawford. During 2022 I conducted what is known as the Rector's Careful Inquiry concerning both Tony and Stephen. This is the first stage in the process for those exploring a call to ordination. I'm delighted to say that I can enthusiastically support both these men as they pursue a call to Holy Orders in the Anglican Church.

Both Tony and Stephen have now met with Bishop Cameron to receive his approval to continue in the ordination process, and both have also completed the next major phase in that process, meeting with a discernment committee of members of Church of the Savior. I'm very grateful to Deacon Andrea Buettner and her dedicated team of volunteers, Anna

Brychik, Michael Galbraith, Carla Hill, Mike Kennedy, Mark Kwolek and Myron Manasterski, for the time and effort they have invested in helping Tony and Stephen discern their next steps.

In early December, following his approval by the COTS Vestry, Tony was given permission by Bishop Cameron to meet with the Diocesan Commission on Ministry, whose approval is the vital stage in the ordination process. That meeting should take place early in 2023. Stephen's meeting with the Vestry will take place at his convenience once he and Abby have become somewhat adjusted to the presence of their newest family member, baby Adriel.

In late October, Andrea and I joined several other COTS members at a special worship service and book signing, held at the Church of the Ascension in Oakland, to commemorate the 50th ordination anniversary of our Archbishop Emeritus, Robert Duncan.

The regular Diocesan Convention took place in November. Our delegation was the same as at the Special Convention, except that Marianne Manasterski replaced Jason Wilson, whose term had expired, as a lay delegate. This year's Convention was uneventful, save for the election of Marianne Manasterski to the Diocesan Council. The Diocesan Council is the body that carries out any functions of Diocesan Convention in between the annual meetings of Convention. The most typical roles of Council are to make adjustments in the Diocesan budget that become necessary during the year on account of unanticipated changes in either expenses or income.

Lastly, Sarah Kwolek continues her excellent service as Diocesan Director of Administration. Anna Brychik also serves on Diocesan staff as an accounting assistant. I am thankful to both Sarah and Anna for their investment in the wellbeing of our Diocese and their service to both clergy and lay members.

BUILDING MAINTENANCE CAMPAIGN REPORT

In 2017 the Vestry established a comprehensive plan for major maintenance, upkeep and improvement for Church of the Savior's building. At the top of the list were crucial needs like roof replacement and masonry repair as well as the compelling concern to improve the appearance of our sanctuary. Initial estimates of the cost of a comprehensive project came to about \$335,000 – in 2017 dollars.

Since then, several new elements – most notably price inflation and early discharge of the building mortgage – have contributed to increasing the cost of the original project. The total estimated cost of all items in the project as it now stands, with present adjustment for inflation is approximately \$507,000.

As of the end of 2022 we had incurred over \$265,000 in expenses on the overall campaign. This figure does not include the nearly \$47,000.00 paid to Sewickley Savings Bank in early January 2023 to obtain discharge of the building mortgage.

You can read about prior years' expenses in our previous annual reports. In 2022 our significant campaign activities included: at the very beginning of the year making a \$50,000 payment to principal on the building mortgage, which reduced the outstanding mortgage balance to around \$70,000; completing the rehab of the sacristy and ambulatory areas behind the stage; refinishing the stage and installing several improvements; and further improvements to the sound system, including reducing the amount of wires exposed to foot traffic on the stage area. I'm particularly grateful to Tony Hermankevich and his crew and to Bill Topper, Jason Wilson and Mark Kwolek for their roles in the rehab of the sacristy, ambulatory and stage. With this work, after thirteen years (!) we finally have a sanctuary that offers a tasteful welcoming space for our members and guests.

In May we filled a second 20 yard dumpster with discarded items from our ongoing building cleanout. During the summer, we were also blessed to host the youth and young adult choirs from First Baptist Church, Birmingham, Alabama, who repainted the basement for us. They came to us thanks to the invitation of Pastor Ken Sachs of God's Field Church, one of our Ambridge Ministerium partners. I'm grateful to Jason Wilson for his work in coordinating the efforts of this visiting team.

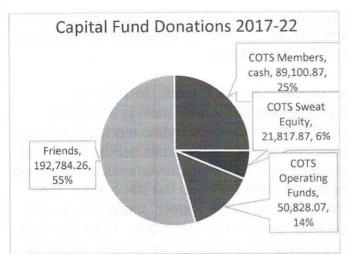
In 2022 we continued to experience increased giving to the capital campaign. In fact, the three highest years of giving to the campaign, both from within the parish and from beyond, have come since the beginning of the COVID pandemic in 2020; and every year the total amount given to the campaign has increased. In 2022 campaign donations increased from just under \$79,000 to over \$102,000! We thank God for his gracious provision!

Here is the breakdown on capital campaign giving from the start to now:

The charts display the overall progress of the campaign through the end of 2022. In all we have raised over \$350,000 toward the goal of \$507,000 (right); so we are over two thirds of the way there! Just under half the amount raised has come from COTS members (next page).





The discharge of the building mortgage early in 2023 will afford us significant opportunities we have not previously had. Elimination of debt service from our operating budget releases an additional \$26,000 a year for ministry in Ambridge — on the assumption that operating income continues to equal or exceed that in prior years.

We can celebrate the substantial progress made in 2022, giving great thanks to God! At the same time, our building campaign has not concluded. Major work remains to be done on

the building façade (brick repointing on the three sides not addressed in 2021) and on floor treatments in the basement, main floor and entrances and stairways. In 2017, the cost of those elements was estimated to be approximately \$120,000; inflation has undoubtedly caused that number to increase significantly. The bottom line is that even as we quite rightly rejoice in the Lord's goodness and provision to us, we need equally to continue to pray, work and give to achieve the campaign goal of a building free of major maintenance needs for the next twenty years.

Notes:

Overall: As in 2022 fixed costs and service fees are projected for another across-the-board increase in 2023. This budget assumes substantial increases in the cost of all utilities (25% or more in the case of electricity (I. 44210) and gas (I. 44220); slightly less for water (I. 44230), telephone (I. 44240) and internet (I. 44260)). Property insurance (I. 43120) is also budgeted at a second consecutive 25% increase. Directors and operators insurance (I. 43110) assumes a 20% increase; we anticipate that workers' compensation will more than double, given that the historic pattern is a low cost year followed by a high cost year, and 2022 was a low cost year.

Finally, on account of persisting inflation this budget also projects a second consecutive 10% wage increase for support staff.

- The projected opening balance for 2023 is based on the end-of-year 2022 operating surplus of \$40,088.90. This amount includes \$8,600 in contributions in memory of Bp. John Rodgers. The Vestry is currently considering whether these funds should be applied to some specific restricted use.
- 2 Assumes a reduction in parishioner donations of about 12% between 2022 and 2023.
- 3 Given the Vestry's current policy of restricting to building fund use all miscellaneous undesignated external gifts, this line item is budgeted at 0 for 2023.
- 4 Assumes NA group monthly contributions (Sunday night, Tuesday noon, Thursday night), at \$20/group/month/4 groups, with some shrinkage

- Assumes we will tithe to the Diocese month-by-month based on prior month's income, as we have done in previous years. 2023 Diocesan godly share asking is \$12,781, which is 10% of COTS' 2021 Normal Operating Income. We have initially committed to a total of \$11,610, which is slightly more than 10% of our projected 2023 operating income. As in prior years, we will communicate this lower amount to the Diocese as our pledge.
